



# **OILING THE WHEELS**

It took GAC Jordan 55 trucks, lots of sleepless nights and tons of careful planning to clear, load and transport a consignment of 106 tons of base oil up country recently.

The shipment arrived at the port of Aqaba in the south, packed in flexi-bags and loaded into 20 containers. It was destined for the Jaber Free Zone in northern Jordan, where leading lubricant company Global Oil Industries has a terminal serving both the domestic and neighbouring markets. **GW**

# **OIL EXPLORATION IN BURUNDI**

#### FLEXIBILITY AND 'CAN DO' ATTITUDE DELIVER SUCCESS

As the search for oil and gas goes further afield, companies have to be prepared for the unexpected – and so do the service providers who support them. UK-based exploration company Surestream Petroleum Limited (SSPL) was glad to have GAC UK alongside for a vital delivery for its Burundi Project.

SSPL needed 60 tons of mixed cargo – ranging from clothes, stores, tools and chemicals to high value sonar equipment and a chase boat – for their ongoing seismic operations on Lake Tanganika. SSPL appointed GAC UK for the job. It also asked GAC to act as main agent for airfreighting stores to Burundi and for a high-priority shipment to and from Malawi.

Kevin O'Shea, GAC UK's National Manager of Specialised Services, says all the freight was first collected at their lpswich warehouse. The main consignment was then sent in containers by sea to Dar-Es-Salaam, Tanzania, where GAC-Seaforth Tanzania handled the land transportation to Burundi's capital, Bujumbura. Selected items were sent by air.



#### Stop-start

The initial delivery timeline was six months but local conditions and the regional security situation made it a stop-start task. Flexibility and a 'can do' attitude were vital.

Kevin says: "A major curve ball was thrown in our direction when it emerged that the dangerous goods in the shipment had not been packed or labeled in accordance with regulations. Undeterred, we worked with the client to get all the goods ready at very short notice.

"Because of the diverse nature of the cargo, the goods were covered by various export licenses which made the booking and documentation processes akin to sitting a rocket science exam."

#### High maintenance

A Surestream spokesman says: "Due to circumstances outside our control, we were quite a challenging customer and we have at all times been grateful for GAC UK's support and responsive communications.

"GAC UK was selected initially based on cost. However, customer confidence adds value. They delivered on our Burundi Project, despite the complications and date changes. Throughout the project, GAC UK coordinated the passage of information from various sources and that has been a real source of customer confidence. We look forward to continuing to do business with GAC UK in the future." ew



# THE TRUTH BETWEEN THE HEADLINES



Undeniably, the Greek people are facing one of their toughest tests. Unemployment is running at around 25% and those in work face tax hikes, wage freezes or reductions and rising utility bills. As a result, the Greek market has taken a hit, with imports plummeting by about 35% in the past two years.

But that's just one side of the coin. The other side is a tale that sounds a note of cautious optimism.

#### **Good news**

Several positive developments have not received the global media attention they deserve, including stories of well-known multinational companies recognising Greece's potential and investing accordingly.

Exports are booming, rising by about 20% during 2012. In combination with reduced imports, this has started to have a positive effect on the country's trade balance. Agricultural exports like olives, olive oil, fruits and vegetables, wines, etc. are among the best in the world and there is a move to form a cohesive marketing strategy to make the most of those precious resources.

In November 2012, the UK-Dutch consumer goods giant Unilever announced that 110 line items currently imported into Greece will be produced domestically – both for the local market and for export.

American IT giant Hewlett Packard will use the Port of Piraeus Free Zone as its redistribution centre for Central & Eastern Europe, Eastern Mediterranean and North Africa. In addition to the port facilities, the Greek train network will be used as part of their distribution strategy, boosting

the country's intermodal transportation solutions and showcasing Greece as a key entry point into Europe.

Piraeus is experiencing massive growth with a 96% increase in productivity at its container terminals in the past year. It is emerging as a hub port for the region. Three of the world's top five container lines now use it for transshipments. Further development is underway to boost the port's throughput.

#### The test of time

There have always been challenges to doing business here. Despite recent efforts to reduce the mass of red tape that has always been part of doing business in Greece, bureaucratic tangles remain daunting. The climate has always been fiercely competitive.

#### More than survival

GAC Greece is ahead in the commercial survival race. From the day of its inception in 1986, it has been the exclusive agent of one of the world's biggest liner companies. We have a very strong presence in the cruise sector (a major contributor to our economy) as well as other sectors like bulk

cargo and international freight forwarding. And we are keeping our eyes open for new opportunities at all times.

The Eastern Mediterranean is now an area of focus in the search for oil & gas. Drilling is already underway in Cyprus and exploration has recently started in Greek territorial waters. Although no results have been announced yet, experts say there are substantial reserves which could secure Greece's energy future. GAC Greece is doing some exploration of its own by looking for ways to integrate our local knowledge with the GAC Group's global energy expertise so we can support the energy sector effectively.

#### It's personal

People are key to our success. GAC Greece is a family business and all 85 members of staff are seen as part of that family.

Our people have years of experience and enthusiasm, which in turn offers a sense of assurance and confidence to customers. Their deep knowledge of the market, understanding of local business, and long-term personal relationships have played a key role in our success.

#### **Looking forward**

The past three years have brought many changes for Greece. Difficult decisions have been taken and unpopular measures put in place. People have suffered financial losses as the result of radical treatments aimed at curing the ills of decades. But though these are tough times, it looks like better days are ahead.

The survival gene is a strong component of the Greek DNA. It is the stamina and creativity of the Greek people that will get the country back on track. And GAC Greece is among those working for a better tomorrow. **GW** 

# MARITIME SECURITY PARTNERSHIPS BOOST VESSEL PROTECTION

GAC Maritime Security (formerly GAC Protective Solutions) has strengthened its non-lethal protective measures with two new products.

#### PirateFence™

A partnership with Mobile Defense Systems LLC provides anti-grapple razor wire to protect vessels from attacks by sea criminals. PirateFence™ is a modular-based perimeter protection system with anti-climb and grapple-resistant components. The coil is applied in sections to avoid any attempts by attackers to peel the system away in its entirety, a common problem with many existing systems.

The system uses Razor Ribbon® with a galvanized steel core and sharp razorblade edges. But its easy-use 'roll' design ensures that the risk of crew injury is virtually eliminated during installation or transportation. The entire PirateFence™ system is purpose-designed to withstand saltwater.

#### **Anti-boarding device**

GAC Maritime Security has also added the P-trap anti-boarding device, winner at the 5<sup>th</sup> Safety at Sea International Awards and a finalist in the Seatrade Awards and Lloyd's List Awards in 2011. Created by Netherlands-based Westmark BV, this patented anti-boarding device creates a secure, non-lethal

barrier around a ship, adding an additional layer of protection from attack.

A set of long, thin lines is carried on side booms extending up to 10 metres from the ship's bow on both sides of the ship just below the waterline. Any vessel entering this security zone will run into these lines, which trap the propeller and disable the engines. Designed to be deployed before entering high-risk areas, the P-trap provides continuous protection against multiple attacks, day and night, without the need for crew involvement or constant vigilance.



#### Systematic and multi-layered

GAC Maritime Security, Powered by AKE, is a partnership between GAC and AKE Group. Christer Sjödoff, Group Vice President, GAC Solutions, says: "We are committed to offering non-lethal vessel protection that can be deployed by vessel owners and operators as part of a systematic, multi-layered approach to sea defense." **cw**

# AFTER THE FLOOD

When floods caused widespread damage and disruption in Thailand, GAC was entrusted with sending some massive gas turbines to Germany for repairs. Now they're back home – once again thanks to GAC.

Five 13-ton turbines were damaged in October 2011 when water surged into the Rojana Power Co. Ltd's site at Ayutthaya, north of Bangkok.

The first phase of their reinstatement is now complete after GAC Thailand delivered two of the turbines using a special aerodynamic "Air Ride Truck" truck to transport them the 85km from Bangkok International Airport to site. Given their size - $5.60 \times 2.60 \times 2.53 \text{ m}$  – and sensitivity, the engines could only be transported at max 60kph. **GW** 

# TINY JEWEL, BIG SPARKLE

At a time when the world seems dominated by doomsayers with dark visions, Qatar offers a gem of good news, casting its light widely.



Qatar has the world's largest per capita GDP. Its economy expanded by 14.8% in 2011, the biggest rise in the world that year. Expansion continued in 2012, albeit at a slower rate estimated at 5.4%, and the International Monetary Fund forecasts further growth of around 4.9% this year. Not bad for a nation of just 11,000 km² that was considered a Gulf backwater a generation ago.

#### **Opening up**

Qatar's influence now extends beyond its borders and it is using its wealth to buy skyscrapers, football clubs, hotels, rare art collections and other status symbols. It is home to the Arab television network Al Jazeera, in itself a high status product. The country's far-seeing leader, Emir Hamad Bin Khalifa Al Thani, plays an increasing role in regional politics.

At home, there are programmes to upgrade the country's educational, healthcare and infrastructure. These include:

# BUDDING ECO-CONSCIENCE STARTING TO BLOSSOM

The choice of Doha to host the United Nations Climate Change Conference in November last year raised a few eyebrows. After all, Qatar is hardly a paragon of greenery. It owes its wealth to hydrocarbons and has the world's biggest carbon footprint per person. Yet some argue it could become a leading green economy.

#### **Reducing emissions**

Despite its huge gas reserves, Qatar is steadily switching to renewable energy sources. The Qatar Foundation was set up in part to move the nation from a hydrocarbon economy to a 'knowledge economy' and billions of dollars are being spent to reduce fossil fuel dependence. Solar panels now power desalination plants and greenhouses. A manufacturing plant to produce polysilicon (used to make solar cells) is well underway.

The Qatar National Convention Centre – where the UN summit was staged – is certified as a Leader in Energy and Environment Design.

Qatar's growing environmental confidence is evident in its plans to host a carbon-neutral FIFA World Cup in 2022 and produce 20% of its energy from renewables by 2024. Big ambitions

are common in the Gulf. Judging by progress so far, these particular goals may well be achieved.

#### Sustainable development

Rising eco-consciousness among Qatar's leaders is also greening up the way the country manages infrastructure developments.

Florida-based CSA Ocean Sciences has been tasked with the world's biggest ever reef relocation job. It will relocate 10,000 corals from within the New Port Project site at Doha to protect them and associated marine life from construction works. It is the latest in a series of reef moves aimed at preserving Qatar's marine environment.

GAC Qatar has worked with CSA on a range of projects during the past ten years. ••

Those policies cover a range of related issues, including:

- HSSE (Health, Safety, Security & Environment)

# GAC PINDAR AND TNL INTERNATIONAL **STRENGTHEN AUSTRALASIAN OPS**

GAC Pindar has announced a tie-up with global freight forwarder TNL International, to deliver specialist marine leisure logistics services within the growing Australasian market.

The partnership, named TNL GAC Pindar, is headquartered in Auckland, New Zealand. It serves Australia, New Zealand and the Pacific Islands, providing services including yacht transportation, superyacht services, air, sea and road freight, agency services and specialist superyacht bunkering.

Freight forwarder Richard Thorpe is the new Manager of TNL GAC Pindar, Australasia. A freight industry veteran, Thorpe has spent nearly a decade in yacht handling logistics across the region.

# O&A WITH JESSIE GONG

# How does your full Chinese name translate into English?

Gong Haiyun. Coincidently, my name is pronounced the same as the Chinese word for "shipping". However, my grandma originally gave me the name to grant me good luck.

# The past decade or so has seen massive business growth for China. More recently, that rate of growth has slowed. Does this mean the Chinese bubble has deflated?

China's business growth has definitely been affected by the crisis starting from 2009 with drops in commodity prices, weak exports and factory closures. In shipping there has been a drop in imports of raw materials, reduced freight and fewer new orders. However, the economy remains steady and continuous urbanisation will generate domestic demand, support the real estate market and general consumption.

#### Head or heart – which rules you?

I am ruled by both my head and my heart. Which one dominates depends on the situation

# What is your home town and what has it gained and lost during China's recent rapid growth?

I'm Shanghai born and raised. The changes it has experienced during past few years have been so great. It has gained the attention of the world, attracting multinational companies to do business here. Thanks to her people's open minded mentality, the city has become accepting of foreign cultures and accommodates different ways of living.

However, everything has a double edge. The city is getting busier but so are the people. The roads have become wider but there is more traffic. Communication is now easier but there is less personal contact.

# How are traditional qualities expressed in Chinese life today?

Some traditional qualities still rule the Chinese. These are mainly the Confucian values of courtesy, reliability, wisdom, loyalty, a focus on family, the Tao theory of balance, cause and effect, etc.

In today's business climate, these principles are more treasured than ever. The faith and ethics of one company decides their future. Without them, the individual or company can hardly survive.

# Is it possible to talk about a country as vast and varied as China as a single entity, or is it a union of different communities and culture? How do business practices differ from place to place?

China has 56 ethnic groups, each of which has a distinct culture, and many have their own language.

Business practices can also vary. For example, in the north, effective business negotiation is often done at the dining table, with toasts. In Fujian Province, opposite Taiwan, people prefer to have tea whenever possible. Further south, people are more inclined to believe in luck and fate. Wherever you are, it is important to pay attention to local customs.

# What do you have to do well to succeed in your business?

Keep good relationships with clients, listen to their needs, build trust, put yourself in your customers' shoes.

Meanwhile, gain trust and support from within, build effective communication, protect and balance the interests of both customer and your own company.

# Do you have a routine that helps you prepare for the challenges of your working day?

Yes, I break down annual targets into each week, and categorise matters in a four-
