The is in reference to the TAMP circular issued for Indexation of tariff caps fixed in the Reference tariff cases under 2013 Guidelines for PPP projects at the major port trusts with reference to the variation in Wholesale Price Index (WPI) vide circular cited in Ref 1 above. The copy of the circular is attached for your ready reference.

As per the TAMP circular, the annual indexation factor for FY23 is 6.46% effective from 01 April 2022 to 31 Mar 2023. Accordingly, our revised tariff of cargo handling charges, berth hire charges & storage charges are tabulated below:
