Regulations

The Immigrants and Emigrants Regulations, 1956, published in the Supplement to the Ceylon Government *Gazette* No. 10, 896 of February 24, 1956 as amended from time to time are hereby further amended as follows:-

- (1) by the substitution for regulation 4 thereof, of the following regulation:-

 - (b) Diplomatic or Official Visa;
 - (c) Educational Visa;
 - (d) Employment Visa;
 - (e) Investor Visa;
 - (f) Medical or Court Case Visa;
 - (g) Non Governmental Organizations (NGO) or International Non Governmental Organizations (INGO) Visa;
 - (h) Religious Visa;
 - (i) Registered Indian Visa;
 - (j) Port Commission Visa;
 - (k) Relation of a Sri Lankan Citizen; and
- (3) Visit Visas shall consist of the following subclasses:-
 - (a) Business Visa;
 - (b) Gratis Visa;
 - (c) Tourist Visa.
- (2) by the substitution for regulation 6 thereof, of the following regulation:-

"6. Every application for a Visa shall be made to the prescribed authority in such one of the Forms set out in the First Schedule hereto, as may be appropriate to the case, and shall contain all the particulars required to be entered therein. The Forms for the subclasses of Visa shall be as follows:-

- Notwithstanding anything to the contrary in paragraph (1)-
 - (a) a person (other than a citizen of Sri Lanka) may be required to pay for a visit visa or transit visa, a sum not exceeding the amount that a citizen of Sri Lanka would be liable to pay for a visa for that country;
 - (b) Where a visit visa or a transit visa is granted or issued to any person by the representative of another Government on behalf of the Government of Sri Lanka, such person may be required to pay for that visa any such sum fixed between the two Governments.
- Where a person (6)
 - (a) who has submitted an application for a Permanent Residence Visa or a Residence Visa, online; or
 - (b) who has submitted an application for a Permanent Residence Visa or a Residence Visa, online but still

such person's application is pending approval,

such person may submit his residence visa applications to the Head office of Department of Immigrations and Emigration, if it is necessary for him to come to Sri Lanka in the meantime. For such purpose, the person may apply for an Entry visa or a landing endorsement or a Visit visa as required for his entry into Sri Lanka.

- (7) There shall be no issuance of a visa under Resident Guest Scheme (RGS), My Dream Home (SSRV) and for a Indian Citizen under section 13 of the Indo-Ceylon Agreement (Implementation) Act, No. 14 of 1967. An extension of above mentioned visa may be provided to existing visa holders.
- (8) (a) A shore pass: may be issued to the crew members of a ship in the territorial waters of Sri Lanka to enter the shore and move around the harbor city. Every shore pass shall be substantially in Form W set out in
